# SUBJECTS OF MODERN WORKING-TIME RATIONING PERFECTION

**Abstract.** The article is aimed at understanding the role and competences of the main subjects who carry out the labor regulation in Russia at the modern stage. The author examines the legal maintenance of labor rationing activity as a system in the Russian Federation. The study of Russian Labor Code allowed allocating three working-time rationing subjects: the state, the employer and the trade union body. The author has studied normative documents regulating the labor rationing system by the state, and has identified them as a recommendation. The study of employer opportunities as the subject of working-time rationing allowed revealing a number of pressing problems. Further restrictions in the activities of trade union bodies were identified. The author identifies scientific advices as the subject of improving the working-time rationing, and shows foreign experience of appeal to the consulting companies with the labor rationing questions. In conclusion, the author lists the current functions of the working-time rationing and determines the characteristics of the development process of work rationing system in Russia at the modern stage.
