## **THEORETICAL AND PRACTICAL ASPECTS IN THE REFLECTION OF THE REINDUSTRIALIZATION PROCESS**

**Abstract.** The article explores various approaches to reflecting the process of re-industrialization, both in Russia's current economic policy and in theoretical papers dealing with various aspects of this phenomenon. As a research method, a quantitative content analysis of official sources of information was used. At the same time during the study, press releases, speeches, interviews, minutes, transcripts of meetings published on the websites of the President of the Russian Federation, the Federal Assembly and federal executive bodies for the period from 2008 to 2016 were summarized and analyzed. The theoretical aspects of the process under investigation are based on the work of Russian scientists who are considering the problem of reindustrialization in their works as well in the period from 2008 to 2016. The result of the study is the identification of the main approaches to reflecting the process of re-industrialization in the theoretical (the scientists' point of view on the process) and practical (state economic policy) aspects, as well as an attempt to determine the similarities and differences between them.
