PROFESSIONAL REHABILITATION OF PERSONS WITH DISABILITIES IN OBEDIENCE TO "ACCESSIBLE ENVIRONMENT" REGIONAL PROGRAMS

Abstract. The article is devoted to the impact of professional rehabilitation on various aspects of people with disabilities life. The article considers ways and methods of solving rehabilitation problems. The regional program "Accessible Environment" is analysed. The study is conducted through considering such problems as the system improvement of comprehensive disabled people rehabilitation and habilitation. As a key indicator of the program implementation, the author determines the proportion of working age disabled people who are employed in the total number of working age disabled people. The author compares the projected indicators in the program with the indicators of the United States, Britain and China. Particular attention is drawn to ways of barriers overcoming in the professional sphere for people with disabilities. The work reflected the issues of forecasting the possible risks associated with the solution of the program's tasks.
